## What is a pharmacy residency program?

Completing a pharmacy residency after graduation is a great way to begin a career in hospital pharmacy practice. A residency is a postgraduate training program, which allows the resident to perform as a licensed pharmacist but to train under the supervision of an experienced preceptor. The cornerstones of any pharmacy practice residency include direct patient care and practice management.

During a residency program, the resident is able to develop skills and competence in providing pharmaceutical care to a variety of patients in various hospital settings, thus accelerating growth beyond entry-level experience. Residency training provides practitioners with a competitive advantage in the job market because trends in health systems increasingly require residency training for hospital positions. Completing a residency gives the resident an opportunity to better define his/her career goals. By participating in a variety of practice areas, a better perspective can be gained on which area of care best fits his or her needs. # What is a postgraduate year one (PGY1) pharmacy residency?

A postgraduate year one of pharmacy residency training is a 24-months organized and directed program that builds upon knowledge, skills, attitudes, and abilities gained from an accredited professional pharmacy degree program. The first-year residency program enhances general competencies in managing medication-use systems and supports optimal medication therapy outcomes for patients with a broad range of disease states. The second-year of the residency program builds on the foundations of the first year and hones the clinical acumen of the resident to enable them to be practice-ready in the healthcare system. The PGY1 Pharmacy Residency Program at Cleveland Clinic Abu Dhabi is in candidate accreditation status with the American Society of Health-System Pharmacists.

### What does Cleveland Clinic Abu Dhabi offer?

The Pharmacy Practice Residency (PGY1) program at Cleveland Clinic Abu Dhabi is designed to allow the resident to gain experience in a variety of practice areas in an acute care environment in order to build and expand knowledge and skills necessary for direct patient care. Residents who successfully complete this program are well prepared for pharmacy generalist positions, specialized residencies, fellowships or other career opportunities.





Residents will get the chance to complete various rotations including, but not limited to:

- Internal medicine
- Critical care
- Infectious diseases
- Cardiology
- Medication safety and quality
- Endocrinology

- Automation and informatics
- Administration
- Ambulatory care
- Transplant Pharmacotherapy
- Neurology

Additional activities include involvement in educational programs such as case conferences, journal clubs and seminar presentations, completion of a research project and participation in hospital committees. Staffing is required every third weekend throughout the residency program.

- Minimum 5-year BS degree in Pharmacy or Pharm. D, minimum GPA 3.0
- Achieving a passing score in the residency entry examination administered through the
- Department of Health (https://fmhsmeb.uaeu.ac.ae/)
   ILETS (6 and above) OR TOFEL (550 and above)

### How do I submit to the program?

To be considered, Candidates must submit the following through the **Tanseeq online application form**:

- Academic transcripts
- Curriculum vitae
- Letter of intent
- Three letters of recommendation
